Notes:

(0) Request 100. On 6/14/23, PFP funded an NGO request for \$1151 in residual PFP “Giving Tuesday 2022” donations for food support of Afghan prosecutors in Afghanistan.

(1) Request 101. On 8/3/23, PFP funded an NGO request for \$3619 in PFP “Donate to Save Lives” (2023) donations to relocate 2 prosecutors and their family members to the host country of Germany. On 11/9/23, this request was extended until 3/1/24 at an additional cost of \$3500, for a new total of \$7119.



(2) Request 102. On 8/3/23, PFP funded an NGO request for \$3500 in PFP “Donate to Save Lives” (2023) donations to relocate 1 prosecutor and their family members to the host country of Germany. On 12/2/23, a supplement was added of \$1500 for passport and visa costs, to a new total of \$500.

(3) Request 103. On 10/26/23, PFP funded an NGO request for \$4680 in PFP “Donate to Save Lives” (2023) donations to acquire travel documents for 13 prosecutors and their family members.

(4) Request 104. On 10/27/23, PFP funded an NGO request for \$1685 in PFP “Donate to Save Lives” (2023) donations to fund travel for 1 prosecutor from Pakistan to Brazil. He was arrested and deported to Afghanistan prior to his flight. A credit remains pending with the travel agency for use by another prosecutor.

(5) Request 105. On 11/20/23, APA funded an NGO request for legal funds to review German denials of Afghan prosecutors. This was funded from APA legal funds not PFP funds.

(6) Request 106. On 12/15/24, PFP funded an NGO request for \$1500 in PFP “Donate to Save Lives” (2023) donations to fund the living expenses of one prosecutor currently in Mexico awaiting a CBP appointment to lawfully enter the USA.

(*) Completion dates with an asterisk are planned relocation completion dates. Actual completion dates are shown without an asterisk and are posted at least 1 month after the relocation on the 1st of a month to avoid displaying operational information.
